It won't raise the grain of wood or loosen wood joints or veneer on fine furniture. Use **CITRISTRIP® Paint Stripper After Wash** after stripping projects to insure beautiful results when refinishing.

DIRECTIONS FOR USE:

1. Follow instructions below regarding ventilation. Wear chemical-resistant gloves and chemical splash goggles.
2. Pour into a metal or plastic container. Dip a stripping pad into wash and clean the surface, rubbing back and forth with the wood grain.
3. Discard and replace the used wash when it becomes cloudy with residue. Continue washing with fresh wash and stripping pad until all residue is gone.

IMPORTANT: Carefully read all directions, notes and cautions prior to use. Only use this product as directed on the label. Do not use for any other purpose. Do not mix with any other product.

HELPFUL TIPS: For best results, use in temperatures between 65° and 85°F and away from strong breeze and hot sun. Protect surrounding areas with a plastic drop cloth. To avoid spills always keep container tightly capped. For best results, apply Paint Stripper After Wash while surface is still damp from stripping.

STORAGE: Store in a cool place.

DISPOSAL: Allow liquid to evaporate and residue to dry outdoors. Then dispose of in metal or plastic container in accordance with local, state and federal regulations.
